1/ Notice Board.

Mr Riddiford offered to do any planing to same if necessary. If the posts that Mr Cole has are not suitable, The Councillors agreed to purchase some suitable wood.

2/ Coast Rd. Weight Restriction.

A letter was read, (dated 23/3/76) from The County Engineers Dept: stating that, he is arranging for an up to date, Traffic count to be taken, and the need for some form of restriction will be assessed. The Clerk was instructed to write to the Dept: yet again, requesting a definite date of the Order & the extreme urgency for this to be enforced.

3/ Clearing Footpaths

The Clerk informed the Council, that Mr H. Waygood, will undertake, the maintenance of the Footpaths this year. He suggested clearing them in June & September, for a fee of £40.

Footpaths.

Mr Cole reported that The Coastal Footpaths towards Clevedon were requiring urgent attention, he had also observed some rather Dangerous points at the Signal Station Area. These areas being the responsibility of The Woodspring District Council. The Clerk was instructed to write to The Department requesting urgent attention:

Regarding the Road repairs to the Coast Road, & a Sign Post, also the Reflectors on the Narrow

Bridge in Moor Lane. It was reported to the Council, that the necessary repairs had been carried out.

5 Village Hall Loans Grant.

A unanimous decision had been agreed by the Council, 1. To give a Grant of £50.00. 2. Plus a Loan of £50.00. This loan to be interest free. The £50.00 to be repaid to the Council within 3 years from the date of receiving the same. An agreement was signed by Councillors R. Dilley (Chairman) A. S. Cole, G. Russell, G. W. Dunn. Mr R. Knight abstained any vote or decision on this matter, as he is connected with the Hall Committee.

6 Precept:-

An application for a Precept of £200 to be paid to Lloyds Bank on June 1st 1976. was signed.

7 The Brook.

Regarding the stretch of Brook (situated in the Coast Road) which was excavated, a letter had been received from The Divisional Surveyor, stating that the site had been inspected, & the main problem would appear to be that some of the coping stones are missing, but he would endeavour to find replacements. The Council felt that Mr Penn had missed the main point of the letter which had been sent to him re: the danger of the sides of this stretch of Brook caving in. Mr Dilley offered to telephone the Department concerning this matter. The Clerk was instructed to write to Mr Penn regarding a point in the Brook in Moor Lane, where it has narrowed a great deal, due to lorries passing at this point.

8 Litter.

Regarding the complaint of litter on the Highway which appears to have fallen from lorries etc. Mr Penn has asked The District Council to investigate this matter.

Item 5

Brook:-

A letter was read from Mr. D. Penn, regarding the stretch of Brook in Moor Lane, which had been narrowed in parts, due to lorries passing over this point. This would be attended to, when there was a machine available in the area.

Item 6

A letter was read regarding the Area of The Signal Station: The dangerous state of the path, which had been reported. This will receive attention as soon as possible.

Once again The Weight Restriction order to The Coast Road, was discussed. This request has been constantly forwarded for a number of years. To date an order has not been implemented. Mr Rowles registered a very strong protest. It was also stated that the Coast Road from The Tree to Charlecombe Park is in urgent need of attention. The Clerk was instructed to contact the Department yet again

requesting urgent action. The Clerk was also instructed to write to Mr Brian Lewis, County Councillor, requesting his assistance in these matters. Mr Dilley proposed that if we do not receive any satisfaction in the near future, that this matter should possibly be referred to our M.P.

Item 2

The Brook widening in Moor Lane as requested to The Dept: This has been completed satisfactorily. Regarding the Brook outside of Church Farm. There is still considerable concern, regarding a grating to prevent ~~only~~ danger, to children. A letter had been received from The Dept: stating that a grating, could collect rubbish. The Clerk was instructed to write again to Mr Perm, suggesting placing a bar, vertically or horizontally to be placed within 2' of the entrance.

Item 3

Regarding the Storm Gulleys at Walton Bay, it was reported that these had been cleared. The ~~Drain~~ Gulleys were still not connected to the Drains. Mr H. Riddiford undertook to bring this matter to the attention of Mr Lee.

Item 4

A Petition signed by 122 Parishioners, regarding the Weight Restriction to the Coast Rd., was received by the Council. The organizer being Mrs Sue Bayow. A letter of thanks for her interest and hard work, was to be sent to Mrs Bayow.

Item 5

Major Newton:- informed the Council that Central Government has made certain decisions in the event of war. There would be 9 regions, Walton-in-Gordano would be number 7. Major Newton discussed the possible areas for setting up Communications etc. The Council agreed in principle, the necessity for a Defence System & plans of communication, if there ever was a war. The Council could not at this stage commit themselves to such a scheme. Major Newton was informed, that the Parish Council as a continuing body, would always be available if ever the need arose. A letter to this effect was to be forwarded to Major Newton.

Item 6

The loan of £50 granted to The Village Hall Committee was repaid. A letter was to be forwarded to them, congratulating them on their achievement.

Item 7.

Grant towards a Motor Mower for the Church Yard. Mr G. Russell retired from the meeting, while this was being discussed. Advice had been received from Mr Moon, stating that the Council were in order to make a grant. Letter 6 - From The Divisional Surveyor, stated that he had spoken to Mr Rowles, concerning the Gullies & Drains at Walton Bay. Any action on this matter, would depend on funds, that may or may not be available.

- 1 Councillor Rowles reported that he is under extreme pressure, from the Residents in the Area, as waste water is still running on to the land in the Area.
- 2 There is a definite Potential Hazard there.
- 3 There had recently been an accident there, which had damaged a Hedge.
- 4 Councillor Rowles stated that at least the first action should be a Grid.
- 5 Councillor Rowles informed the Council, that unless action, by The Divisional Surveyor was taken within two weeks, he would have no alternative but to resign from The Parish Council, & possibly take private action. The Clerk was instructed to write to The Dept: informing them of this.

2 The problem solved completely.

Councillor Rowles, withdrew his previous proposed, resignation. He stated, he would not attend meetings, until, this urgent matter was resolved.
